Texas eNotary Instructions

Identifying Information

- Notary Applicant must provide full name exactly as documents will be notarized.
- Notary Applicant must provide street address (including county).
 - **IMPORTANT:** Applicant must be a Texas resident.
- Notary Applicant must provide social security number.
- Notary Applicant must provide date of birth.
- Notary Applicant must provide valid driver's license number (state of license must also be provided).
- Notary Applicant must provide email address.

Statements Relating To Qualification

- Notary Applicant must be at least 18 years of age.
- Notary Applicant must be a legal resident of Texas.

Notary Public Surety Bond

Name and address of agency must be provided.
 IMPORTANT: To expedite processing of the eNotary request, provide the RLI producer number next to the agency name.

Errors and Omissions

• **RLI Insurance Company** offers Errors and Omissions coverage in the amounts of \$5,000, \$10,000, \$25,000, or \$35,000.
